Digital Society, Social Innovation and Global Citizenship

THE RECTOR

CONSIDERING its Decree n. 1642 of 10 April 2025, which published the Call for Application for admission to the joint master's degree programme in ***Digital Society, Social Innovation and Global Citizenship (DIGISOC) - Class LM 92 (Master Programmes in Theories of Communication)***, jointly activated at the Department of Social Sciences of the **University of Naples Federico II**, at the **Leopold-Franzens-University of Innsbruck**, and at the **Palacky University of Olomouc**, for a total of **90** places, and, in particular, art. 8 which provides, among other things, the following:

The Committee shall select candidates for admission to the Master Programme based on the selection procedure and in accordance with the established admission criteria.

Successful candidates will be enrolled at all three awarding universities. To complete their enrolment, candidates must meet the admission requirements of each institution. Enrolment is finalized only upon payment of the required tuition fees.

CONSIDERING the D.R. n. 3130 of 07 July 2025, appointing the Admission Committee for the above public selection;

CONSIDERING the D.R. n. 3192 of 10 July 2025, approving the admission ranking to the joint master's degree programme in Digital Society, Social Innovation and Global Citizenship (DIGISOC);

NOTED that the candidates listed in the following table, after further checks by the Admission Committee, do not have the requirements to enroll in the three universities that issue the joint master degree:
